COOPERATIVE EQUIPMENT AGREEMENT INFORMATION

COOPERATOR AGREES TO:

- **Sign a Cooperative Agreement with the Mississippi Forestry Commission.**
- **Convert equipment into Fire Apparatus or Emergency Unit.**
- **Paint equipment and put into service within 6 months.**
- **Provide shelter adequate to protect equipment from vandalism and adverse weather.**
- **Obtain, prior to operation, liability insurance on equipment and continue in effect for duration of cooperative agreement.**
- **Ensure that equipment is used for Fire Use and Emergency Response ONLY.**
- **Take ownership of all equipment acquired. Vehicle Titles will be transferred to the VFD or Authorized Entity (and not an individual's name) after final inspection by the Mississippi Forestry Commission.**
- **Each Cooperator will be responsible for payment of a Processing and Handling Fee of \$100.00 for each VEHICLE Acquisition.**
